This has reference to the proposal submitted by Maharajah's College (A) Yelugubanti Vari Street Near Clock Tower Vizianagaram-535001 affiliated to Andhra University, Visakhapatnam for extension of autonomous status under the UGC Scheme for Autonomous Colleges.

The Commission in its meeting held on 16.10.2019 decided to extend the autonomous status to Maharajah's College (A) Yelugubanti Vari Street Near: Clock Tower Vizianagaram-535001 affiliated to Andhra University, Visakhapatnam for a period of w.e.f. 2019-2020 to 2021-2022, including ex-post-facto approval for the period 2017-2018 to 2018-2019.

Further, it may be noted that the above said college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.
